C) The Lessee is fully responsible to provide close, PERSONAL SUPERVISION OF THE CHILDREN PLAYING IN THE INFLATABLE UNIT TO ENSURE THEIR SAFETY AT ALL TIMES. -Lessee agrees to be in charge and fully responsible for any accidents, injury or damage rental merchandise is in possession of the Lessee.
D) No Silly String, gum, candy, food or any other sticky substance is allowed in the Inflatable Unit . ***A Special Cleaning Fee will apply for non-compliance.***
E) The Inflatable Unit may not be moved from the place where it is originally installed. If the Inflatable Unit shifts, pull, by its corners back to the original location.
******The Inflatable Unit MUST BE kept away from Swimming Pools and Electricity Cables*******
F) Lessee agrees to have examined the Inflatable Unit (s), has found it/them to be in good condition and agrees to return the Inflatable Unit (s) in the same. Any damage resulting in Loss of Rental to Polinarios Party Rental will be Charged to the customer.

I hereby certify that $I$, being a competent, assuming risks of my own free will, being under no compulsion or duress, have read and understood the Rules as listed above and the Waiver and Assumption of Risk.
